	Section 2. That the rights herein granted are subject to the exercise of the police power as the same now is or may hereafter be conferred upon said City.
	Section 3. That this ordinance shall be in full force and effect, and shall constitute a binding contract between the City of and North Dakota Telephone Company when it shall have been enacted according to law, and when the provisions hereof shall have been accepted in writing by said North Dakota Telephone Company and such acceptance filed with the City Auditor.
