President Thomas called the regular commission meeting to order at 6:00 P.M.

Pledge of allegiance was recited.

Dockter motioned to approve the agenda. Simon seconded. Upon roll call, all members present voted aye. Motion carried.

Dockter motioned to approve the May 13th commission meeting minutes. Hapip Jr seconded. Upon roll call, all members present voted aye. Motion carried.

Simon motion to approve the June 3rd special commission meeting minutes. Dockter seconded. Upon roll call, all members present voted aye. Motion carried.

Hapip Jr motioned to approve May financials. Dockter seconded. Upon roll call, all members present voted ave. Motion carried.

Dockter motioned to approve the planning & zoning recommendation for a deck variance for Wes & Camey Johnson. Hapip Jr seconded. Upon roll call, all members present voted aye. Motion carried.

Roger Neslon was present to discuss purchasing eight lots in Heritage Heights. His main concern was how the city was looking to finish the block up there. The infrastructure would be the responsibility of the developer and then recouping costs for the specials when they sold the lots. Eric will look at getting an updated figure for the cost including all curb, gutter, asphalt, etc for services to those eight lots.

Seeds of Eden was present to give an update on a recent event that occurred. They provided their housing policy and procedures and went through some of that. There was some concern of how they handled certain individuals and who was allowed to be in their facility. The public is looking for more transparency and meaningful answers. Seeds of Eden is trying to be more impactful in the community and working within the community.

Hapip Jr read all changes to Ordinance 149A – Pet Ordinance. These changes occurred in Section 11, Section 12 - The first violation will be a \$500 fine and the second violation will result in the animal being removed and humanly euthanized, Section 14, Section 18, and Section 27. Thomas motioned to accept the first reading. Dockter seconded. Upon roll call, all members present voted aye. Motion carried.

Hapip Jr presented a policy for commissioners. This is a guideline to all incoming or existing commissioners that is meant to be helpful and keep effective commissioners. Items that need to be voted must be place on the agenda. Dockter motioned to accept these guidelines for current and future commissioners. If things needed to be added they should be brought before the

commission to take official action. Weber seconded. Upon roll call, all members present voted aye. Motion carried.

Adam provided a list of roughly 8100 square feet of asphalt to be repaired around town. The timeline for this would be in August. Simon motioned to approve the estimate from Quality Asphalt Repair, Inc for \$67,864.00. Dockter seconded. Upon roll call, all members present voted aye. Motion carried.

Riverside Park Road Slide Area – The 5K for the Geotech study is included in the cost. Is this something the commissioners would like to pursue? There is a special road fund program that is available to help pay for some of the work.

Lead & Copper Revision Rule- submission date was pushed back to August 1st. A closeout meeting will be had with the city.

2023 Street Improvement Project- Final pay application and balancing changes will be done and the final pay application will be submitted for July.
